



# MUNICIPALITY OF AKSEHIR AND AKSEHIR ASSOCIATION OF PHOTOGRAPHY AMATEURS (AKFAD) 10th INTERNATIONAL PHOTO CONTEST

## 1. Name of The Contest:

Municipality of Aksehir and Aksehir Association of Photography Amateurs (AKFAD) the 10th International Photo contest .

## 2. The Purpose and Subject of The Competition:

The Purpose; 65. Within the scope of the International Akşehir Nasreddin Hodja Festival, the theme of "Labor and Human", which will be organized this year, 10th with the international photography competition, it is aimed to contribute to the world photography art by sharing our emotional moments such as joys, sorrows, uncertainties and waits in our lives. In addition, it is aimed to contribute to the art of photography in our country and the world by sharing the economic returns and the moments we have experienced by giving love and effort in return for the sweat we have spent to manage our lives.

## 3. Organization:

The competition will be organized by Municipality of Aksehir in association with Aksehir Association of Photography Amateurs (AKFAD) (referred to as the REGULATORY institution) and will be held with the support of the Turkish Photographic Art Federation (TFSF).

## 4. Categories:

Competition has only one section; digital color or digital black and white photographs. All color and black and white photographs will be evaluated together.

## Digital: Labor and Human (Color and B/W)

## 5. Competition Conditions:

- **a.** PICTURES CREATED BY ARTIFICIAL INTELLIGENCE ARE NOT ALLOWED IN THIS SALON! It is reminded that all parts of the image have to be photographed by the author who is holding the copyright of all works submitted. Offenders will be sanctioned for life! by FIAP and TFSF.
  - b. Participation for the contest is free.
- **c.** The competition is open to the participation of all amateur and professional photographers from all over the world, except for the TFSF competition representative, the organizing committee, the members of the Selection Committee and their first-degree relatives.
- **d.** The participants who are currently filed under TFSF restriction for any of the above defined reasons, or the participants who are on the FIAP red list are not allowed to participate in this contest. Before the jury is evaluated, the organizer will check the FIAP Red List and the TFSF Contest Representative will check the TFSF Red List and identify the people who are on the restricted list and will go to elimination.
  - **e.** All participants can submit up to 4 (four) photographs for the contest.
- **f.** Manipulated photos will not be considered. Some minor processes such as color, sharpness, dust removal, contrast settings, and reasonable photographic interventions are accepted. The documentary structure of the photograph must not have been changed.
  - g. Photos created by montage of more than one photo (collages) will not be accepted.
- **h.**Panoramic photographs created by bringing together and producing more than one photograph are accepted for the competition only on condition that real images taken at the same time are used.
- I. Participants are obliged to take all kinds of administrative and technical measures for the processing and transfer of personal data in accordance with the Law on the Protection of Personal

Data(KVKK). In this context, in the case of processing photographs of a real person, the persons must be informed within the scope of the Law and their explicit consent must be obtained in cases where their explicit consent is required. Taking photos of people who can be seen in the photos submitted to the competition and sending them to a competition; It is accepted that they allow the photograph to be published in visual, internet and printed media. Responsibility for photographs that are not transferred in accordance with the Law belongs to the participant.

- **j.** The participant accepts, declares and undertakes that the photos uploaded for the competition belong entirely to him and that all permissions have been obtained. All kinds of interventions and changes that use images belonging to someone else as they are or partially, to present the artwork as its own even though it does not belong to it, and to mislead the evaluation board, are considered violations of the rules.
- **k.** "Additional sanctions to the main directive for the organization of the turkish photographic art federation national / international photo contest and the directive on rule violation applications tfsf yg 02-d" are applied to those who violate the rules. The participant's awards, titles and all kinds of gains are taken back. The place of the canceled prize is left blank. The situation is reported to FIAP. If participant has been awarded, the participant must return the award.
- I. By participating in a competition approved/sanctioned by TFSF and FIAP, the contestant is deemed to have accepted in advance that the compliance of the photographs submitted to the competition with TFSF and FIAP rules and definitions can be determined if necessary. TFSF and FIAP may conduct this investigation using all means and techniques at their disposal. In the event that the participant fails to provide the necessary information requested, does not submit the original file taken with the camera, or does not collaborate with TFSF and FIAP in resolving the issue, the participant will be banned by TFSF and FIAP for violating the rules, and their name will be publicly disclosed in any form.
- **m.** It is recommended that the EXIF information (such as DPI, pixel information) of the photos uploaded to the competition system of the organizer be kept intact to facilitate possible investigations. Otherwise, the regulatory institution and the TFSF are not responsible for the problems that may occur in the system.
- **n.** The organizer, may request high-resolution digital files of the photos that are awarded or accepted from the participant.
- **o.** The organizer may decide to cancel or postpone all or part of the competition under conditions it deems appropriate. The regulatory body has the right to determine the methods and rules to be applied in cases of cancellation or postponement. The regulatory body is authorized to make all kinds of changes, including the rules of the specification, program changes, evaluation, and awarding, when deemed necessary, in the solution of problems and uncertainties, provided that it informs the TFSF Competitions Unit in writing at least one week before the deadline and obtains its consent. In this case, informing the FIAP Patronage service and getting approval will be done by the organizer.

# 6. Right of Publication And Copyright (Use):

- **a.** The right of publication, use and exhibition of the photographs that received awards (award, special award, honorable mention and acceptance) in the competition and for which the purchase was applied will belong to the organizer together with the owners of the work. The right to use the work cannot be sold/transferred to a third person or institution. These works will be kept in the archive of the organizer.
- **b.** Participant; From the date of the conclusion of the contest, the photographs that are entitled to receive awards and acceptance must be processed as defined in Article 21 of the Law on Intellectual and Artistic Works No. 5846, reproduction defined in Article 22, dissemination defined in Article 23, representation defined in Article 24 and 25. The financial rights of transmission to the public by means of the sign, sound and/or image transmission defined in the article, aswell as in accordance with other relevant legislation, in the promotion of the regulatory institution in the internet, visualand written media channels with out limitation of place and content, and in the publications of the name and the name of the work (In some instance like photo collage, graphics etc. the name of the author cannot be used). During this period, the right to use the works will belong to the organizer together with the owner of the work.
- **c.** For the work isused in this way, the owner of the work shall not revoke the right of use of the awards and exhibitions specified in this specification and shall not prevent the use ofthe work in the above manner, or that he or she hasno further claims of rights and receivables from the regulatory

institutions and sponsors for thispermission/consent, andhe/she irrevocably accepts, declares and undertakes thatit will not make moral or monetary claims.

- **d.** The participant accepts, declares and undertakes that the photographs he/she sends/uploads for the competition belong entirely to him, that theywere taken by himand that all permissions have been obtained. All legal responsibility of copyright violations that may arise in case of using the images belonging to someone else as they are or partially belongs to the participant.
- **e.**The Author (participant) declares, accepts and guarantees that the work is his own original work, that third parties do not have any rights on this work, that the rightson his work have not been transferred before, and that the owner of the work (participant) is legally responsible in case of a contrary request by third parties. it does.
- **f.** It is accepted that permissions have been obtained to take photographs of elements such as architectural structures, works of art, human faces, which are used as objects in the photographs sent to the contest, to send them to a contest, and to publish the photograph on the internet and in printed media. All responsibility for disputes that may arise due to such uses belongs to the participant.
- **g.** Award-winning and accepted photographs will be published on Municipality of Aksehir's <a href="http://www.aksehir.bel.tr">http://www.aksehir.bel.tr</a> AKFAD's <a href="http://www.akfad.com">http://www.akfad.com</a> and TFSF's <a href="https://sonuc.tfsfonayliyarismalar.org/">https://sonuc.tfsfonayliyarismalar.org/</a> addresses. In addition, it willbe published in the social media (Facebook, Twitter, Instagram, etc.) accounts of organizer and TFSF for promotional purposes and in accordance with the purpose of the competition. In addition, the awarded photographs will be used in TFSF publication E-Almanak 2023 and inf, socialmedia accounts, websites and as posters/billboards/ rackets.

#### 7. Other considerations:

- **a.**The photographs will be presented to the jury members in a completely dimmable hall; it will be presented on a screen with a diagonal length of at least 1 and at most 2.5 m with a projector with a resolution of 1080p: 1920x1080 pixels or on LCD monitor of at least 42 inches with are solution of 1920x1080 pixels,
- **b.** The organizer is as meticulous aspossible in sending e-mails, awards and digital catalogues, but cannot be held responsible for any damages that may occur during the delivery of the award and catalogue. Participants accept that the addresses they use during the contest application are the legal residence addresses that are the basis for any delivery to be made in this way. The organizer does not accept any responsibility for the issues arising from the incorrect reporting of addresses by the participants.
- **c.** On the issues that are not addressed in the specifications, the decisions taken by the TFSF Board of Directors and the Organizing Committee shall be applicable together with the TFSF National/International Contest Regulatory Standards Directive <u>"Turkish Federation of Photographic Art (TFSF) Main Directive for Organizing National / International Photography Competition"</u>
- **d.** Participants; By signing up to <a href="http://www.tfsfonayliyarismalar.org/">http://www.tfsfonayliyarismalar.org/</a> and uploading their photos, they are deemed to have read and accepted the conditions of the competition. This entry rules comes into effect when the participant sends his/her photographs to the competition. Participants do not have the right to object to the provisions of this entry rules afterwards.

## 8. Submittal of Photographs:

- **a.** Since the competition will be held according to the online photo system, no alternative submissions (e-mail, cargo, hand delivery, etc.) will be accepted.
- **b.** Contest, photos will be sent online (online) by following the membership and photo submission instructions at <a href="https://tfsfonayliyarismalar.org/tr/uye/giris">https://tfsfonayliyarismalar.org/tr/uye/giris</a>
- **c.** In order to upload photos to the relevant page, it is necessary to become a member first. The finalization of the membership will be made by clicking the activation link that will be sent to your e-mail address from the system after you become a member.
- **d.** Previous members will use their old username and password. If the password is forgotten, a new password can be created from the forgot password link <a href="https://tfsfonayliyarismalar.org/en/member/password-operations/forgot">https://tfsfonayliyarismalar.org/en/member/password-operations/forgot</a>
- **e.** While participating in the web page, all participants must tick a box next to which the following text is stated:

"I hereby expressly agree to FIAP document 018/2017 « Conditions and regulations for FIAP Patronage » and FIAP document 033/2021 « Sanctions for breaching FIAP regulations and the red list ». I am particularly aware of chapter II « Regulations for International photographic events under FIAP patronage » of FIAP document 018/2017, dealing under Section II.2 and II.3 with the FIAP participation rules, the sanctions for breaching FIAP regulations and the red list."

- f. The sizing and naming processes of the photos to be uploaded during the participation should be done in advance, and the files should be kept ready and uploaded in a single session.
- **q.** The photos to be uploaded must be without mats and margins. Name, signature, logo, date, etc. related to the identity of the participant on the photograph. Information should not exist.
- h. The photos that will participate in the competition must be saved in JPG/JPEG format, 72-300 DPI resolution, 8-12 compression quality, and the size of the files should not be less than 1 Mb and should not exceed 4 Mb.
- I. When uploading photos to the system, "Photo Name", "Place Taken" and "Date Taken" information must be written in the relevant fields for each photo in the form opened. This information is taken as the basis of the participant's declaration. Misrepresentation is considered a rule violation.
- i. The name of each photo file must be a maximum of 31 characters. The characters C, Ğ, İ, Ö, Ş, Ü, ç, ı, ğ, ö, ş, ü should not be used in naming. English letters and underscore ( ) can be used. It is recommended to use the name given to a photo with the same photo name.
- k. In case of errors caused by the system or the user during the process of becoming a member or participating in the competition over the Internet, the frequently asked questions at https://tfsfonayliyarismalar.org/tr/sss/kategori/yarisma-katilim-tr should be examined and if a solution cannot be found https://tfsfonayliyarismalar.org It is necessary to provide detailed information about the problem by using the contact form at /en/iletisim address. This contact form should only be used for resolving potential problems. Submitting a photo via the contact form does not mean you have participated in the competition.
- I. The organizing committee will not be responsible for possible problems that may arise from uploading the works.
